The last day to pay i your 2019 property taxes without a penalty is January 6, 2020. 2% interest accrues on January 7th, 2020 plus additional interest of .75% on the first each of thereafter until paid. In order to penalties, avoid please make sure the legal and memo amounts on checks are correct.

The Town has made improvements in our financial reporting the past few years in an effort to more clearly present this information to the Public. As part of these efforts, the documents created by the Town were recognized by national governmental finance review boards resulting in multiple awards recognizing our commitment to financial transparency.

The Town has received the Certificate of Achievement Financial Reporting (CAFR) award four years in a row beginning in fiscal year 2015. According to the Governmental Finance Officers Association (GFOA), "CAFR recipients go beyond the minimum requirements of generally accepted accounting principles to prepare comprehensive annual financial reports that evidence the spirit of transparency and full disclosure."

In fiscal year 2017, the Town created a more understandable version of the Annual

Financial Report. The GFOA's Popular Annual Financial Reporting (PAFR) program recognizes high quality financial reports specifically designed to be readily accessible and easily understandable to the general public. The Town received the PAFR designation in both fiscal year 2017 and 2018, and hope to achieve this for FY19.

The most recent financial award received by the Town is the GFOA Distinguished Budget Award. This award recognizes high quality budget documents that meet national standards. The Town's first submission was fiscal year 2018. We were fortunate to receive this designation and hope to achieve this honor again for fiscal year 2019. There were 54 award winners from the State of North Carolina for fiscal year 2018 - the Town of Biltmore Forest was the local government with the smallest population to achieve this certificate.

The Town is proud of these awards, and to provide transparent and discernible financial information. The Town is most appreciative of Assistant Finance Director Helen Stephens and her steadfast approach to preparing these documents. Ms. Stephens works tirelessly to ensure the accuracy, clarity, and validity of each piece of data that is submitted. Public Works would like to welcome Jeff Glover as the newest addition to the Public Works team. Jeff started in September and is doing a great job.

Please place all garbage in trash bags. This helps with proper loading into the truck and reduces injuries for personnel. Between the two sanitation personnel, they collect over 500 tons of garbage per year. Please do not place garbage in the recycling containers, only recyclable material. Thank you. The Town provides two dumpsters for residential use. Please only place household garbage in the dumpsters and do not place any items outside the dumpster. This makes it very difficult for the collector. Please note the unauthorized materials list posted on the sign next to the dumpster if you are unsure what is allowed.

Brush collection has stopped and will start back on January 15, 2020.

Leaf pickup has begun. Please place leaves on the road shoulder in front of your property. Please do not mix brush with leaves. After the conclusion of the Christmas holiday, trees will be picked up by Public Works. Please place them at the end of your driveway and we will haul them off for you.


**North Carolina Law:**

## **HOLIDAY SAFETY**

The holiday season is upon us. This is a time of family and fellowship but this is also a prime time for criminal opportunity. Burglaries and thefts increase during the holidays for many reasons. Everyone is in a hurry and our self-awareness is low. Criminals know that we carry more cash and we are making large purchases. All of this adds up to a recipe for criminal activity. The Biltmore Forest Police Department would like to give you a few holiday safety tips. As always do not hesitate to contact us with any questions or concerns.

#### **At Home**

Don't hide spare keys in mailboxes or planters, or under doormats.

Ensure that dark areas and entrances have outdoor lights that are turned on after dark or are activated by sensors.

Keep trees and shrubbery trimmed so they do not conceal doors and windows. Remember, overgrown foliage can provide a hiding place for criminals.

Consider safe deposit boxes for coin and stamp collections, seldom-worn jewelry, stock bonds, etc.

Be sure to mail cards, checks or gift certificates from the Post Office or at a blue U.S. Postal Service collection box.

Lock your vehicle and remove all the valuables. Yes, even in your driveway.
