## Traffic Pattern Changes Coming to Vanderbilt Road

Last winter, the Town conducted a transportation study aimed at addressing current and future traffic and transportation concerns within the Town. As part of this study, public input was sought through survey and online mapping tools. The Town received 246 responses to our survey (15 percent of the total population) – residents were notified through the Town's newsletter, CodeRED notifications, and a direct mailing with links to the survey and how to obtain hard copies at the Town Hall.

The intersection at Vanderbilt Road and Busbee Road was identified as an intersection that needed better traffic control measures. The Board of Commissioners discussed this intersection specifically at their regular meetings, and in July directed staff to develop an action plan for implementing an all-way stop at this intersection. This will require ALL vehicular traffic to stop at this intersection, not just those traveling west or east on Busbee Road. The anticipated timeline for this work to occur is as follows:

PROPOSED IMPLEMENTATION SCHEDULE

 Installation of New Signs and Themoplastics (per attached diagrams) – By the end of September.

•Re-Striping of Busbee Road from Hendersonville Road to Forest Road, and Vanderbilt Road from Cedarcliff Road to Lone Pine Road – By October 21, 2022

•Removal of Additional "New Traffic Pattern" signage and flagging – By October 21, 2022

We appreciate everyone's patience and understanding as we work to begin this implementation. The purpose of this new traffic pattern is to ensure safety of all those using the road – pedestrians, drivers, and bikers.

# New Uniform Trash Containers Are Here!



### <u>Update Your Contact In-</u> formation with the Town!

The Town wants to know how you want to receive information. We strive to provide timely and important information to all residents via our website, CodeRED notifications, and newsletters - but we understand that not everyone wants to receive information in the same way. We have created a new, online web form that will let you update your communication preferences with the Town and let us know whether you want some or any information included within the Town's Directory. Simply visit the Town's website at biltmoreforest.org and click the "Update Citizen Contact Information" link under the RESIDENTS tab on the front page. We want to make sure everyone in Biltmore Forest has an opportunity to stay connected and learn about upcoming events, meetings, and projects within the Town. Help us help you!

Public Works Department staff began distributing new trash containers to all residents in the middle of August. The Board of Commissioners approved the purchase of uniform trash containers for all residents as part of the FY22 budget. Shipping and logistical delays pushed the arrival of these 95-gallon containers, and we are still awaiting delivery of the 65-gallon carts selected by residents. Our vendor has provided a mid-October estimate for delivery. As soon as the containers are delivered to the Town, we will distribute those to residents who selected the 65-gallon container.

Residents were previously provided opportunities to choose between a 95gallon container and smaller, 65-gallon container. Notices were sent via the Town's newsletter and CodeRED notifications, informing all that if they *did not* choose a 65gallon container they would receive the 95-gallon container.

### Important Items to Note

\*Utilizing uniform containers helps prevent injuries to Town Public Works staff. These containers can be rolled into a lift on the rear of each garbage truck - the lift then tips the can into the truck, thereby eliminating the need for staff members to lift bags out of a non-uniform can. Your use of the Town provided, uniform container directly helps protect Town employees and ensures they are not injured by lifting bags out of non-standard containers or by sharp objects that may be in the bag.

\*As a result, once a uniform container has been delivered to you, the Town will no longer accept trash placed in a non-uniform container.

\*All trash should be bagged and placed into the container - loose items should not be left within the can. This helps ensure the materials do not blow around within the truck and helps keep the Town free from litter.

\*Your new trash container can be left in the same location where it has previously been picked up - staff will still pick up in the same manner as has occurred.

\*By providing these containers in larger sizes, we are hopeful it will benefit residents who have utilized more than one trash can.

Once all containers are delivered, the Town will retrieve old containers from residents who no longer want them. Old containers will not be picked up until after all new containers are distributed. If you would like to request that the Town remove your old containers, please contact the Public Works Department at (828) 274-3919. You will be placed on a list and your old container removed when that process begins.

# Greenwood Park Stream Restoration Update

"What is going on in Greenwood Park? When it will it be done, and why hasn't anyone been there for the past few weeks?" These are just a few questions received over the past several weeks as construction on the Greenwood Park Stream Restoration project has slowed. Work is approximately 90% complete, but an underground utility conflict between the Town's designed storm water repair and Duke Energy's underground power has led to a delay. The good news is that the project engineers have designed a revision and we are now just waiting on delivery of the storm water pipe necessary to complete this work.

#### **Background for Project**

The Town has worked on stream restoration within Greenwood Park for several years. The first thrust of this project was a loan application from the Town to the Division of Water Quality in April 2019. This loan application was approved for \$292,000 at zero (0) percent interest. Subsequent to that award, the Town contracted with WithersRavenel consultants to design an appropriate stream restoration for this segment. The project design was approved by the Division of Water Quality and United States Army Corps of Engineers in mid-summer 2021, and a funding approval was granted by the NC Local Government Commission in December 2021. Bids were received and an award made, contingent on LGC approval, in October 2021. Baker Grading and Landscaping, from Old Fort, N.C., was awarded the contract.

#### **Construction Phase**

Construction began in May 2022 with most hardscape improvements being completed by the latter part of July 2022. The one exception to this work is the above referenced utility conflict that had to be redesigned. Once these utility installations are complete, work will begin on other landscaping pieces in the park. Final landscaping associated with the stream restoration project is scheduled to conclude by the end of October 2022. This project is beneficial for many reasons, but three primary purposes are:



1.) Remove the dangerous and end-of-life span gabion baskets supporting the stream bank, and restore the bank to a more natural condition

2.)Improve water quality within the stream, and slow siltation of the stream down via wetland storm water control measures and the use of large boulders

3.) Ensure the viability of the stream and park for generations to come. The Town has produced a PowerPoint presentation - most recently presented at the Town's regular Board of Commissioners meeting in August 2022 - that covers this stream restoration project. We encourage all citizens to read through this presentation and feel free to inquire with questions, comments, or concerns. We want Greenwood Park to be re-opened as quickly as possible, but are also excited about the significant improvements being made through this project. #### Additional Improvements

In addition to the stream restoration project, the Town is also excited about additional improvements for Greenwood Park. Several of these components were discussed during the Town's master planning process (conducted in 2019) for the park, and several are new additions. The Town will have more information and direction on this portion of the project within the next several months.

News from Skyland Fire Department

Greetings from Skyland Fire and Rescue. As summer draws to a close we would like to remind everyone that cool nights are right around the corner. Now is the time to have those heating units and fireplaces cleaned and serviced. Check smoke detectors and Carbon Monoxide detectors to ensure proper working order. Know that firefighters are available to assist with safety inspections of homes if you have concerns. Skyland firefighters have been busy through the year and we recently underwent an audit by the North Carolina Department of Insurance. We are proud to announce that our insurance rating was raised from an ISO Class 3 to an ISO Class 2 which could result in insurance savings for business and homeowners in our fire protection district. This is an overall rating given to fire departments reflecting how prepared they are to respond to a fire. Class 1 being the best rating and Class 10 being the worst. Just over 400 fire departments in the US have obtained a class 1 rating and less than 10 percent of all the fire departments in the US obtain a Class 2. Check with your insurance carrier to see if you could save based on the rating change.
